# Accessibility conformance declaration: Confirmation of WCAG 2.1 compliance of mosparo Spam Protection

We hereby confirm that we, «Access for all» (<u>www.access-for-all.ch</u>), Swiss foundation for technology adapted to people with disabilities, have tested the mosparo spam protection mechanism version 1.1 (<u>https://mosparo.io</u>) for compliance with WCAG 2.1 by the W3C. The mechanism was tested in two scenarios: 1) as visible checkbox, and 2) as invisible verification. **Both scenarios are currently fully compliant with all success criteria at levels of conformance A and AA.** 

#### Method

During the period from February 14<sup>th</sup> to 22<sup>nd</sup> 2024 we reviewed mosparo for accessibility, in particular:

- User testing regarding general contrasts.
- User testing on Windows High Contrast Mode.
- User testing with keyboard only (incl. focus visibility).
- User testing by blind accessibility experts using various screen reader technologies:
  - o JAWS and NVDA on Desktop
  - VoiceOver (iOS) and TalkBack on Mobile

We validated submits with spam detection (by entering a flagged keyword, i.e. "Bitcoin"), as well as submits without spam detection.

For the visible checkbox scenario: we validated both invalid submits (by not selecting the mosparo checkbox) and valid submits (by selecting the mosparo checkbox).

## **Preconditions and restrictions**

All reviews were based on the Web Content Accessibility Guidelines (WCAG) 2.1 (<u>https://www.w3.org/TR/WCAG21/</u>), levels of conformance A & AA. This includes requirements for people with disabilities in all four areas, visual, auditive, motor and cognitive impairments. Testing took place on different combinations of screen readers and browsers.

## **Final test results**

The final test of mosparo spam detection on February 22<sup>nd</sup> 2024 revealed the following state of accessibility:

- Full compliance with all WCAG 2.1 success criteria on level of conformity A
- Full compliance with all WCAG 2.1 success criteria on level of conformity AA
